

Corporate Rules

Additional Enrolment Terms and Conditions

Goodstart Early Learning Ltd (Goodstart) and an organisation approved by Goodstart (Organisation) have collaborated to offer a discount on childcare fees as nominated by Goodstart (Corporate Discount), under the terms and conditions outlined below. These terms and conditions are in addition to the terms and conditions contained in Goodstart's Enrolment Form and to the extent of any inconsistency, these terms and conditions prevail.

Who is eligible?

- Corporate Discount will apply, subject to the terms and conditions below, if:
 - you are a current employee of the Organisation (or if the Organisation is an incorporated association, a current member of the Organisation); and
 - you are a current (or have applied to be a) primary account holder or secondary account holder with Goodstart under Goodstart's Enrolment Form; and
 - your Enrolment Form is (or has been) accepted by Goodstart; and
 - you consent to these Corporate Rules.

When will the Corporate Discount apply?

- If your Enrolment Form is accepted by Goodstart, the Corporate Discount offered by Goodstart will be applied to the normal applicable childcare fees (as determined by Goodstart from time to time), from the date of acceptance. If you are a current account holder of Goodstart, the date of acceptance is the date that the Organisation confirms to Goodstart that you are a current employee or member of the Organisation.
- The Corporate Discount will not apply to any fees prior to the date of acceptance.
- The Corporate Discount is only applied to payments of fees made by Ezidebit.
- The Corporate Discount:
 - is made available at Goodstart's discretion. The rate offered may change from time to time; and
 - offered at a particular Goodstart Centre may differ from a discount offered at another Goodstart Centre; and
 - may differ between the different rooms/age groups at a Goodstart Centre.
- Goodstart is not obliged to offer a Corporate Discount at every Goodstart Centre.

Who do I contact?

- To enquire about the Corporate Discount, you must contact Goodstart's Corporate Enrolment's Team:

- Goodstart will inform you whether there is any vacancy at a particular Goodstart Centre and inform you of the rate of any Corporate Discount available.
- You may be required to attend a tour of the Goodstart Centre as part of the application and enrolment process.
- If you are eligible for a Corporate Discount, you are not given priority of access.
- The Corporate Discount that you receive or are eligible to receive is confidential.

Will the Organisation be contacted?

- Before accepting an enrolment and/or confirming the Corporate Discount, Goodstart may contact your employer to confirm your employment or membership status.
- You consent to Goodstart obtaining information about your employment or membership status from the Organisation (including start and end dates), from time to time, in accordance with the terms of the Notification of Personal Information Collection in your Enrolment Form, or at **www.goodstart.org.au/privacy-policy**.

What happens if my employment or membership with the Organisation ends?

- If your employment or membership with the Organisation ends for any reason, you must notify your Goodstart Centre Director on or before the date your employment or membership ends and state the end date of your employment or membership.
- The Corporate Discount will be revoked on and from the date your employment or membership ends and will default to the normal applicable childcare fee.

Can the Corporate Discount be revoked?

- Goodstart may immediately revoke the Corporate Discount if you do not comply with these terms and conditions and the terms of the payment agreement in your Enrolment Form.
- If any agreement or arrangement between Goodstart and the Organisation regarding Corporate Discounts ends for any reason, Goodstart will provide you with at least 4 weeks' notice that your Corporate Discount will cease, after which time your fees will default to the normal applicable childcare fees and no Corporate Discount will apply.

Are there any other exclusions?

- The Corporate Discount does not apply to applications for, or current enrolments of, before and after school care or vacation care.
- Holiday discounts or any other offers or discounts are not available in conjunction with the Corporate Discount.
